MINUTES

CLASS A COMMITTEE November 30, 2021

The Class A Committee of the Georgia High School Association was called to order at 10:00 a.m., on November 30, 2021, at the GHSA office in Thomaston, Georgia, by Executive Director Dr. Robin Hines to come up with a plan for Class A reclassification.

NEW BUSINESS

After calling the meeting to order, Dr. Hines asked Associate Director Don Corr to go over the proposals that were discussed at the last reclassification meeting. Corr summed up several ideas that were discussed before the issue was tabled at the Nov. 18 meeting.

Crews then asked how many more Class A private schools were likely to withdraw from the GHSA. Petroski said he had heard of at least six more indicating they may leave.

Much discussion then ensued and it became obvious that the issue of having too few football and softball teams left in the Class A private division to have a meaningful playoff was the biggest issue for the private school representatives.

Hanson and Queen voiced their opinion that the only "fair" solution was to apply the 3.0 multiplier to all Class A schools and let them play in whatever classification their multiplied reclassification number warranted.

Dr. Hines pointed out that the committee's mission at this meeting was to work out a plan for Class A, not to come up with a plan that would affect Classes 2A and 3A also.

Drew pointed out that the multiplier came about in order to help balance the playing field in the classes above Class A (which has split championships) and said he thought putting private schools together with public schools would be a "step backward."

Several plans and ideas were brought forward by different members of the committee, but the private school representatives kept coming back to using the 3.0 multiplier on all schools and "letting the chips fall where they may."

"We already have the highest multiplier in the country," said Lowery. "And it was put in to level the playing field, we were told. Well, then we should use it and see how it works. There is only one solution to this issue – use the multiplier and move schools out of A into 2A and 3A."

Crews answered by saying, "If we come up with a plan that reconfigures what we have done in 2-3 classes, then we are going to have a problem."

After much more discussion and exchanges of ideas, the committee settled on the following proposal:

Apply the 3.0 multiplier to all Class A private schools only and let those schools fall into the classifications where that multiplied reclassification number puts them. Then, still using the reclassification number, the remaining schools in Class A (public and private) would be divided by size into two divisions (large and small) with each playing for a separate state championship. These teams would be placed in eight (8) regions for regular-season play, but would be broken out into the large and small divisions for the playoffs based on a yet-to-be-determined "power rating" system. Under this plan, no teams will automatically be moved down from 2A or 3A when the Class A private schools that are multiplied out of Class A come into that classification. But schools in any of the affected classes will be given an opportunity to appeal out of that classification.

That proposal was approved by the committee by a 9-1 vote, which Crews voting "no."

After much discussion about whether or not this proposal would be approved by the Reclassification Committee and/or the full Executive Committee, the committee decided to come up with a backup plan.

Called "Plan B" by the committee, this plan calls for Class A public and private schools to be placed into the same regions (the number of which will be determined later) for regular-season play, but then to be split into separate public and

private brackets for state playoffs. The number of teams in the Private school playoff bracket would be dependent on the number of teams playing that particular sport. Care would be taken to try to prevent overly-large regions, which is why more than the normal eight (8) regions might be required.

Also, as part of the Plan B proposal, the service areas of Class A private schools (only) for transfer eligibility would be returned to the county in which the school is located instead of the recently-adopted public school service area in which the private school resides.

The committee approved Plan B unanimously, but still voted to submit the first proposal as their No. 1 choice to the Reclassification Committee.

The Reclassification Committee can approve, deny or modify either of these proposals, or come up with a different plan entirely. After the Reclassification Committee makes it's decision, any schools affected by whatever plan is adopted for Class A would then be given an opportunity to appeal its placement.

Dr. Hines thanked the committee for their long day's work and the meeting was adjourned.
