APPEALS**1. The Walker School**

The appeal was submitted using an incorrect calculation of an opponent's win total, and percentage used for opponents' wins in games lost. As such, the appeal had incorrect data and is denied.

2. 1st Presbyterian

The appeal was submitted based on a game result that was omitted from the final results. The original calculation was 14.51, and the revised score is 14.53. This appeal is approved.

3. Baconton Charter

The appeal was submitted do to a missing game result of an opponent (Terrell Co.). After recalculating the points with the missing game included, their score was revised from 15.99 to 16.14. The appeal is approved.

4. George Walton Academy

The appeal was submitted do to a calculating error by MaxPreps. After recalculating the points, the GWA score was adjusted from 9.59 to 9.60. The was approved.

5. Excel Christian

Based on the GWA appeal, the 9.60 score created a tie with Excel Christian based on the MaxPreps rankings on 10/13/15. As such, the Excel Christian score was recalculated and the revised score of 9.58 was validated.

6. Mt. Vernon Christian
